How to Submit / Rules of Contest

By submitting an entry, each contestant agrees to the rules of the contest and states that she/he is 18 years old or older. All entries must be salable.

1. Entries. Entries will be accepted from active members of the Main Line Camera Club. Your photographs can be any image that you think is notable. Photographs that violate or infringe upon another person's rights, including but not limited to copyright, are not eligible. Suggested categories are animals, details, history, landscape, people, structures.

2. Entry Fee. There is a \$30.00 entry fee for one to three photographs entered; \$5.00 for each additional entry. Limit of five photographs permitted. Payments by credit card, PayPal, cash or check at time of entry. One to three pieces will be accepted into the show. Thus all entrants will have at least one piece accepted into the show.

3. Entry Format. All entries must be submitted digitally by August 17, 2018. Photograph images must be high resolution (300 dpi) in JPEG format. Digital image size must be at least 10 inches along the longest dimension. Any image with a watermark will not be accepted. Submit via email or deliver to Beauty Art Gallery on SD Card, flash drive or CD. Email to info@beautyartgallery.net

4. Judging. Entries will be judged for:

Delivery of Accepted Photographs:

Photographs chosen for the exhibition must be presented at Beauty Art Gallery on or before the submission dates (Sept. 27 to 29).

Please submit framed photographs, wired, ready-to-hang. Aluminum prints on a "floating" hanger are also allowed.

Photographs can measure up to 16 x 20 inches maximum (320 square inches). Mat and frame up to 4 inches wide may be added. If your work requires a larger size, please call to discuss.

Agreement, Sales & Liability:

Submitting an entry constitutes agreement with all the conditions of this exhibit. Beauty Art Gallery assumes the right to use digital images of any accepted work for publicity purposes.

1. All works will be available for sale.
2. Sale of photographs displayed at Beauty Art Gallery must be conducted through the gallery. The Gallery will retain 40% of the final sale price for all framed works.
3. Sale of cards and prints offered at Beauty Art Gallery will be conducted through the gallery. The Gallery will retain 50% of the final sale price for cards and prints.
4. Artist agrees to use of a digital image of her/his work for the promotion of this exhibit.
5. Although Beauty Art Gallery handles artwork with care, Beauty Art Gallery assumes no responsibility for damage or loss of work while in transit or during the exhibition.
6. Beauty Art Gallery is monitored by security system.
